Burial Space in The Flynn Cemetery Flynn Cemetery Road, Whiteville, NC

THIS CONTRACT AND AGREEMENT TO PURCHASE RIGHTS FOR BURIAL, made and entered into this ____ day of _____, 2_____, by and between The Flynn Cemetery Association, Inc. of Columbus County, North Carolina, hereinafter referred to as "Owner," and the undersigned Purchaser whose signature and address is as indicated below, hereinafter referred to as "BUYER," and;

WITNESSETH:

WHEREAS, SELLER is the Trustees of the Flynn Cemetery Association, Inc. and is the legal representative in matters for the Flynn Cemetery and is therefore authorized to provide burial space for the interment of human remains in the cemetery property to the Buyer as follows:

The Buyer has requested the rights for burial in the following non-transferable _____ plot(s) in Section _____, Row No. (s) _____, _____. See attached listing for name of individual persons to be buried in each plot.

Purchase Price for the right to be buried for each 5' X 10' plot is to be \$_____.

Upon receipt, the sum paid shall become a contribution to the Flynn Cemetery Perpetual Care and Expense Fund maintained by the Trustees of the Cemetery to be used for the upkeep and maintenance of the cemetery property.

Should the Buyer decide, subsequent to the date of this agreement, not to be buried at the cemetery, a copy of this agreement must be returned to the Owner along with a written request indicating the decision. Upon receipt of the written request, the Owner will refund one fourth of the purchase amount and this agreement shall become null and void.

A map of "plot location" (showing recorded measurements) shall be provided to the Buyer at time of purchase with a copy being retained by the Owner for future reference.

This agreement is subject to the By-Laws of the Flynn Cemetery Association, Inc. and the Rules and Regulations that are adopted by the Trustees of the Association. Said By-Laws and Rules and Regulations being subject to change and revision as deemed by the Trustees to be in the best interest of the Cemetery. The By-Laws and Rules and Regulations in force at the time of burial shall apply to this agreement.

This agreement is not transferrable.

Receipt of a copy of the By-Laws and Rules and Regulations of the Cemetery in effect on the date of this agreement is acknowledged by the Buyer's signature below.
